Attachment 2: SUMMARY OF MAY FEDC COUNCIL WORKSHOP

FEDC joined Freeport's Town Council on May 23rd to discuss annual goals and budget for Fiscal Year 2023-2024. Thank you to Board President Mary Davis and Board members Becky Doten-Lizotte, Candice Rinaldi, Leanne Barschdorf-Nichols, Jason Sulham, and Stefanie Millette for participating. It was wonderful to have such strong attendance.

FEDC's presentation was well-received by the Council. While the Council could not take formal action, the discussion was positive and revealed general consensus in support of FEDC's goals for coming year, as summarized below in the final slide of our presentation deck.

The *Catalyst Site Community Design Charette* action item will require further refinement and could take a different form, such as an iterative, pop-up, tactical urbanism approach.

Board Request: To consider allocating FEDC staff time to promote and coordinate program in collaboration with Town Finance Department.

Activate Your Space Fit-Up Grants

Goal

Empower local businesses, both new and existing, with matching funds to make needed improvements to Downtown commercial spaces to enhance business vitality, expand and diversify Freeport's offerings, activate underutilized spaces, and enhance the experience of residents and visitors

Eligible Projects

Redevelopment, restoration, and reconfiguration of commercial properties throughout Freeport's Downtown, such as utility connections, accessibility improvements, space reconfiguration, façade upgrades, signage, updates for code compliance, and more.

Available Funding

\$60,000 in total is available for multiple projects

Projects are eligible for up to \$10,000

Town grant funds must me matched 1 to 1 with private investment

Application and Award Timeline - 2023

Announce Opportunity September

Application October - November

Committee Review December 1, 2023

Awards Announced December 15, 2023

Following the first cycle above, applications will be reviewed on a rolling, monthly basis as funding remains available.

Implementation

Spring / Summer 2024

Project Selection

FEDC will staff the program on behalf of the Town in coordination with Town Finance Director.

Applications will be reviewed by a representative and knowledgeable "Grants and TIF Committee" appointed by the Town Council, or similar


Projects must comply with all relevant codes and regulations

Grant recipients must be in good standing with the Town

Project budgets must be based on multiple quotes from qualified contractors

A clear evaluation criteria will be established to rank applications based on project qualifications, public benefit, and impact

Re: Proposal for Capital Improvements Planning for Transit Oriented Development District

Dear Brett;

We have appreciated the opportunity to work with the Town to strategize how best to fund the upgrade of the wastewater system, which supports future growth and development in the Town. The collaboration by the Town and the Freeport Sewer District to investigate how best to manage future rates while also seeking funding sources that are unique to each will best serve the community. Through this process, we have had the chance to discuss future capital planning needs with both you and Adam Bliss.

As requested, we have put together a scope of services for initial development of an overall capital plan for the Town's proposed Transit Oriented Development District. We believe this work can set the stage for developing the a Tax Increment Financing District and determine the financial needs to support build-out of the water, wastewater, stormwater, and vehicle and pedestrian infrastructure. It also may help support targeted grant opportunities like the Economic Development Administration or future Congressional Directed Spending funding.

SCOPE OF SERVICES

The capital plan will consider sewer, water, storm drainage, streets, utilities, traffic safety, and pedestrian safety and accessibility. The conceptual transit-oriented development districtincludes:

- Parcels located within one quarter mile of transit stations, including the Metro Breeze stops in front of Maine Beer Company, Town Hall, and the L.L. Bean Flagship store on Main Street, and the Amtrak Downeasster Station off Depot Street in Downtown Freeport
- Parcels located within 500 linear feet of U.S. Route 1 between the Main Beer Company Breeze station and the Town Hall Breeze station.

Woodard & Curran agrees to provide the following services:

- Obtain all available infrastructure plans along the TIF District from the Town and local utilities.
 - Town provided layers include:
 - Sidewalks and trails
 - Storm drains



- Catch basins
- Drainage management areas
- Parcels
- Crosswalks
- Local utilities
 - Maine Department of Transportation
 - Freeport Sewer District
 - Maine Water Co.
 - Unitil
 - CMP
- Create a plan showing all the existing infrastructure and identify any gaps in the infrastructure.
- Develop a budgetary level opinion of cost to infill infrastructure gaps and to upgrade existing infrastructure (if readily apparent).
- Attend up to 2 meetings with the Town.

Woodard & Curran agrees to provide the following deliverables:

- A plan showing existing infrastructure and identified gaps in ArcGiS or in a format compatible with ArcGIS applications.
- Spreadsheet(s) of infrastructure gaps and financial calculations to support the budgetary level
 opinion of cost to infill and upgrade infrastructure as identified in Scope of Services above.

PROPOSED FEE & SCHEDULE



Woodard & Curran proposes to perform the work described within this proposal for a not-to-exceed fee of \$5,000 inclusive of reimbursable and direct expenses and billed monthly for the percentage of work completed.

Work can begin within 15 days after Authorization to Proceed and is anticipated to be completed within 75 days.


